SUBJECT	Procedural Policies for Adoption

PURPOSE:

1. To advise Members that as part of ongoing policy development work, several gaps in provision of procedural policies have been identified.

3. To advise Members that apart from the Rules for Public meeting (remote/virtual), and Social Media and Web Site Policies, all others are documents are held by Yorkshire Local Council Association as standard documents, and are available to be adopted by Town Councils
4. To advise Members that the Rules for Public meeting (remote/virtual) is one that has been refined to reflect Covid 19 restrictions and the move to holding virtual meetings, and the Social Media and Web Site Policy refined to include the Web Site and Members involvement in Social Media.

BACKGROUND:

5. Members are aware from previous reports that as part of our continuing improvement in governance, further policy work is required. Whilst mainly in the HR area, there are also several gaps in procedural, type policies and some of these are addressed in this report.

6. As progress continues it is likely that further Policies will be identified and will be brought for adoption as part of an ongoing project.

7. Whilst there are none directly arising from this report, it is good practice to have a suite of such policies in place that help defend any potential legal challenge to Town Council process.
