SUBJECT	Appointment to Outside Bodies and as Trustees	

#### **PURPOSE:**

1. For Members to agree appointments to Outside Bodies and to act as Trustees on specified external bodies.

## **BACKGROUND:**

- 2. The unprecedented impact of the Covid 19 virus requires forward planning to ensure the Council has agreed the Appointments to Outside Bodies and to act as Trustees on specified external bodies for the 2020/2021 Municipal Year.
- 3. Whilst there is no precedent for this taking place outside of May, this is pragmatic effort to be both reasonable and fair.

#### **RECOMMENDATION:**

- 4. That Full Council agrees the Appointments to Outside Bodies and to act as Trustees on specified external bodies effective from the 16<sup>th</sup> May 2020 as per Appendix 1 and to vote through "en bloc"
- 5. That Members waive Standing Order 5b requiring the meeting to take place in May and for the Appointments to Outside Bodies and to act as Trustees on specified external bodies for the 2020/21 Municipal Year to take place in March, effective from May 16<sup>th</sup> 2020

## REASONS FOR RECOMMENDATION

6. Full Council approval is required to agree the Appointments to Outside Bodies and to act as Trustees on specified external bodies.

7. Normally Members would agree in May, who is to serve on Outside Bodies and to act as Trustees on specified external bodies, but given the circumstances involving suspension of normal committee business effective from the end of this meeting, it is appropriate with agreement of Members, to resolve this issue now so that on return to normal council business, Members are duly authorised to do so.
