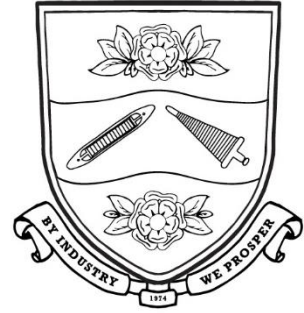

2019(CEC)004	<p><u>ITEM 4. Declarations of Interests</u> To receive disclosures of personal and prejudicial interests from members on matters to be considered at the meeting. Officers are required to make a formal declaration about council contracts where the employee has a financial interest.</p> <p><i>None Declared</i></p>
2019(CEC)005	<p><u>ITEM 5. Public Participation</u></p> <p>To adjourn the meeting to allow members of the public to make representation on the business of the agenda for the meeting. No resolutions can be under public participation.</p> <p><i>Diane Tremayne supported the Climate Emergency Committee’s approach that there will be extensive inclusion and consultation going forward, especially involving younger parties. She said it was important to focus on what we can do rather than what we cannot. Updates of successes could usefully be on the Town Council website. Her daughter was also present and it was noted she had joined the recent activity of absence from school on a Friday in order to participate in protest reaffirming her strong interest in this matter.</i></p> <p><i>Cllr K White updated Members regarding potential school’s involvement, including at Primary level. A general view was expressed to listen to a wide audience including the Green Party, and if appropriate hold meetings at other venues in order to reach a wider audience and to be seen to be involving the community.</i></p>

Exclusion of Press and Public - Public Bodies (Admission to Meetings Act) 1960</u></p> <p>To consider and confirm any agenda items that require the exclusion of the Press and Public in accordance with the Public Bodies (Admissions to Meetings) Act 1960 for matters appertaining to confidential or exempt information.</p> <p><i>Proposed by: Cllr A Hollis and Seconded by Cllr M Holmstedt Unanimous</i></p> <p>RESOLVED:-</p> <p><i>That the agenda items for the meeting do not require the exclusion of the press and public and that they be allowed to remain for the duration of the meeting.</i></p>
2019(CEC)007	<p><u>ITEM 7. Terms of Reference</u> To confirm the Terms of Reference passed at Full Council are still relevant to the work of this Committee.</p> <p><i>There was discussion about the detail of the Terms of Reference. Cllr M Holmstedt clarified it should be 7 councillors plus the Mayor as ex-officio and not 6 councillors. She also mentioned that it does not include methane gas as well as carbon dioxide. Cllr A Hollis said it should also include greenhouse gas emissions as an overall phrase. The Town Clerk agreed to amend the Terms of Reference and Objectives with these details.</i></p> <p><i>Cllr G Kent suggested that the Terms of Reference and Objectives should remain otherwise as they are until further discussion can take place.</i></p>

Scoping of Programme of work and frequency of meetings for this committee</u></p> <p>To consider what activities and areas of work this committee wishes to address.</p> <p><i>The meeting addressed other agenda items before returning to this item, There was a great deal of discussion about what should be included within the scope. This included the handling of waste, protecting the natural environment and energy consumption.</i></p> <p><i>It was agreed that this would be worked on in an informal scoping meeting to take place on 14th October 2019 before bringing a more defined proposed scoping and programme of work to the next formal committee meeting.</i></p> <p>Action: <i>Town Clerk to arrange venue of Community College 14th Oct 2pm.</i></p>
2019(CEC)009	<p><u>ITEM 9. Membership of Committee</u></p> <p>To consider inviting outside persons/bodies to be part of the Committee as co-opted Members.</p> <p><i>There was a great deal of discussion about who should be involved and whether they should be co-opted. It was decided that suggestions be forwarded to the Town Clerk and then following discussion, invites could be issued.</i></p> <p><i>To perhaps focus on ensuring youth representation, those with expertise in specialist areas of climate related knowledge and those already working on climate issues in key groups,</i></p> <p><i>The Town Clerk agreed to check what the quorum for Councillors should be in respect of co-opted Members also participating to ensure Councillor majority for decision making.</i></p>
2019(CEC)010	<p><u>ITEM 10. Frequency of Meetings and Structure</u></p> <p>To consider the frequency of meetings and future structure for delivery of tasked items. membership of co-opted Members to the group and the frequency of meetings to be held.</p> <p><i>It was discussed that as there is a requirement to consult and involve people as much as possible, that there should be informal working groups to share information and make recommendations to the Committee, where formal decisions would be made. Cllr The Revd. G Kent suggested the possibility of a Citizens Assembly.</i></p> <p><i>The Town Clerk suggested a framework to reflect the Committees drive towards as much informality and action as possible by:</i></p> <p><i>4 - formal meetings of the Climate Emergency Committee each year</i> <i>4 - formal working groups to feed into the Climate Emergency Committee</i></p> <p><i>Supported by ad hoc informal meetings to generate discussion and thought to determine what needs to be brought to working groups including consultation / networking with other organisations such as local schools, art groups, other Calderdale Town Councils.</i></p> <p><i>The Climate Emergency Committee meeting and Working Group Meetings would be clerked formally .Informal meetings would be member led and not requiring formal clerking to support.</i></p> <p><i>Members agreed this approach and asked for a timetable to be developed for this so that the meetings could report back appropriately.</i></p>
